

## BUTT-SMITH MEDAL GUIDELINES

The Butt-Smith Medal, a joint initiative of CSIRO Exploration and Mining (CSIRO EM) and the Cooperative Research Centre for Landscape Environments and Mineral Exploration (CRC LEME), acknowledges the outstanding contributions of Dr Charles Butt and Dr Ray Smith to geoscience and mineral exploration, especially in the area of regolith science.

### **Purpose**

The award recognises outstanding and sustained contributions linking regolith science to exploration in Australia.

### **Career Stage**

It is expected that a research and/or applications track record of at least 10 years would be required in order to meet the outstanding and sustained criteria.

### **Periodicity**

The Award is made every two years.

### **Each Recipient to Deliver an Address**

Since the award is for outstanding and sustained research, each recipient will give a prestigious lecture on the scope of his/her work at an appropriate venue or conference. There will also be opportunity for the recipient to present at other events during the two years.

### **Eligibility**

Eligibility is open to researchers who, for the majority of their careers, have been working on Australian mineral exploration issues, whether Australian citizens or otherwise.

### **What Would Constitute an “Outstanding and Sustained Contribution”?**

In deciding the award, focus will be on significant initiatives and outcomes and take into account one or more aspects that characterise the careers of Charles Butt and Ray Smith. These could include in various combinations:

- advancing the science through R&D
- a series of important scientific papers
- an important text book
- a major course with impact through graduating students
- successful applications
- discovery
